We will conduct 2 tests during 2024 to verify Glennis Care meets the criteria on 170.315(b)(10). One test will encompass testing a single export of EHI; a second test will encompass testing EHI for all individuals. Within each test, we will ensure that the exports are available to only a provisioned user and available on demand when the user wants. In addition, we will verify the data within the export matches the data in our system, and that the data is in a machine readable format.
